On June 24, 2021, the Public Service Commission of the District of Columbia ("Commission") issued Order No. 20762 holding in abeyance the Office of the People's Counsel for the District of Columbia's ("OPC") Petition for the Commission to Open an Investigation into the Reasonableness, Safety, and Prudence of Washington Gas Light Company's ("WGL") Handling of Natural Gas Leaks on its Distribution System.\(^1\) In Order No. 20762, the Commission, inter alia, directed a technical conference be held to discuss the differences between the various information reported in the Leak Identification, Detection and Repair, and Odor Complaints ("LIDAROC") reports, Pipeline and Hazardous Materials Safety Administration ("PHMSA") annual report and Natural Gas Quality of Service Standards ("NGQSS") reports.\(^2\) Additionally, parties were directed to discuss what, if any, additional reports or reporting requirements should be adopted.\(^3\) In accordance with the Commission's directive, a Technical Conference is scheduled for **Thursday, September 2, 2021, from 11:00 a.m. to 12:30 p.m**. The Technical Conference will be held virtually via Microsoft Teams.
