

Distribution Rates for Small Commercial Customers Increase Effective April 16, 2014; Standard Offer Service Rates Decrease Effective June 1, 2014

Pepco's Standard Offer Service (SOS) supply rates for District of Columbia small commercial customers will decrease for customers on Schedules GSLV ND, T, SL, TS and TN starting June 1, 2014. If you have not chosen an alternative electricity supplier, you are on Standard Offer Service and Pepco buys electricity for you, charging you rates approved by the District of Columbia Public Service Commission. The cost of Standard Offer Service supply is shown in the "Generation Services" and "Transmission Services" portions of your electric bill.

The new rates are based on market prices obtained through a competitive bidding process overseen by the Public Service Commission. Providing an average dollar-amount increase or decrease for commercial customers is not meaningful, since use varies significantly among the many sizes of commercial customers. Under Generation Services, the Administrative Charge that was previously included in the kwh rate is listed separately.

Please note that summer rates take effect with the billing month of June. Pepco, as with many other utilities, charges different rates for electricity use in the summer (June–October) and in the winter (November–May).

Below are the SOS rates for small commercial customers that take effect on June 1, 2014.

In addition, Pepco's Distribution rates increased, effective April 16, 2014. The net effect of the decrease in SOS rates and the increase in Distribution rates is an overall bill decrease for SOS customers.
