## FORMAL CASE NO. 988, IN THE MATTER OF THE DEVELOPMENT OF UNIVERSAL SERVICE STANDARDS AND THE UNIVERSAL SERVICE TRUST FUND FOR THE DISTRICT OF COLUMBIA

- 1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that on November 13, 2013, the District of Columbia Universal Service Trust Fund Administrator ("DC USTF Administrator"), Rolka Loube Saltzer Associates ("RLSA"), filed a letter with the Commission<sup>1</sup> ("RLSA Letter") discussing a request by the District Department of the Environment's Energy Office ("DDOE") to be reimbursed \$1,000 from the 2014 DC USTF Budget for printing and duplicating costs.<sup>2</sup> This \$1,000 was not included in RLSA's Proposed 2014 DC USTF Budget filed on October 1, 2013.<sup>3</sup>
- 2. The RLSA Letter notes that in DDOE's Response to Order No. 17246, DDOE requests that the DC USTF contribute \$1,000 in printing costs for the Utility Discount Program ("UDP") flyer/brochure, which will include information about Lifeline service. In its Letter, RLSA expresses the opinion that adding the \$1,000 to the 2014 DC USTF budget will not have an effect on the recommended contribution factor of 0.0037 but should be addressed by the Commission as an allowable item to provide certainty for the DC USTF Administrator and DDOE. RLSA believes that the inclusion of the requested \$1,000 contribution is a policy decision to be made by the Commission.<sup>4</sup>
- 3. All persons interested in commenting on DDOE's request that the DC USTF contribute \$1,000 in printing costs for the Utility Discount Program ("UDP") flyer/brochure that is not currently included in the Proposed 2014 DC USTF Budget may submit written comments and reply comments not later than seven (7) and fifteen (15) days, respectively, after the Commission's issuance of this Notice.
