PUBLIC NOTICE OF HEARING**FORMAL CASE NO. 1179, IN THE MATTER OF THE INVESTIGATION INTO WASHINGTON GAS LIGHT COMPANY'S STRATEGICALLY TARGETED PIPE REPLACEMENT PLAN,**

1. Through this Public Notice, the Public Service Commission of the District of Columbia (Commission) gives notice of a hearing regarding Washington Gas Light Company's (WGL or Company) Request for Approval of its District Strategic Accelerated Facility Enhancement Plan (SAFE Plan or the Plan).¹ The hearing is scheduled for September 30, 2025, and will be either evidentiary or legislative in nature, depending on what we determine in a separate Order issued at a later date.

2. The subject of this case is the Application that WGL filed on September 27, 2024, the District SAFE Plan, which seeks authorization to undertake targeted replacement of certain vintage materials on its system and to recover the costs associated with the Plan through the previously approved surcharge mechanism for WGL's accelerated pipe program. WGL indicates that through its SAFE Plan, the Company intends to replace 12 miles of main and replace or remediate an estimated 2,612 service only, 966 service replacements with main, and 554 Service transfers in its distribution system over the three years of the plan, at a total estimated cost of \$215 million.

3. By Order Nos. 22003² and 22434,³ the Commission set forth the procedural schedule in this matter. This Public Notice alters the date of the hearing to September 30, 2025.
