## SUPPLEMENTAL PUBLIC NOTICE OF VIRTUAL CYBERSECURITY CONFERENCE

**April 23, 2021** 

- 1. Through this Public Notice, the Public Service Commission of the District of Columbia ("Commission") supplements the March 12, 2021, Public Notice establishing a Virtual Cybersecurity Conference<sup>1</sup> to discuss, among other topics, best practices that telecommunications, electric, and natural gas utilities are taking to protect their infrastructure from cybersecurity threats. This Commissioner-led virtual Conference is scheduled for Wednesday, April 28, 2021, from 2:00 p.m. to 4:00 p.m.
- 2. The conference will consist of two panels. The first session is **"Washington DC Utilities Overview: How are Our Local Utilities Preparing for Cybersecurity Threats?"**. We will hear from each of our regulated utilities, Verizon, Pepco and Washington Gas Light Company, on their cyber risk management program, and discuss what stakeholders need to know about how utilities are preparing for attacks on their information networks and control systems.
- 3. The second session is "Industry Cybersecurity Overview: Energy Delivery Systems" and will be moderated by Chairman Willie Phillips. The panel will highlight the top emerging cybersecurity risks in the energy industry and discuss how national agencies are working with the utilities and other stakeholders to prepare for attacks on utility systems. Panelists will include:
  - a. Manny Cancel, Senior Vice President, North American Electric Reliability Corporation, and CEO of the Electricity Information Sharing and Analysis Center (E-ISAC);
  - b. Steve McElwee, Chief Information Security Officer, PJM Interconnection; and
  - c. Joseph McClelland, Director of Office of Energy Infrastructure Security (OEIS), Federal Energy Regulatory Commission.
