1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that, on January 30, 2018, Washington Gas Light Company (“WGL”) filed its 2017 annual report¹ for WGL’s vintage coupling replacement and encapsulation program (“Program”) approved in Order No. 15627.²

2. The 2017 Annual Report contains a summary and four attachments: a confidential schedule that provides detailed, project-specific information for each project through December 2017; a guide to follow the detailed, project-specific schedule; a summary of the Program; and information on the percentage of main completed, percentage of services completed, and percentage of dollars spent.³

3. All persons interested in commenting on the 2017 Annual Report may submit written comments and reply comments no later than 30 and 45 days, respectively, after the issuance of this Notice.
