**FORMAL CASE NO. 1182, IN THE MATTER OF THE INVESTIGATION INTO THE
IMPLEMENTATION OF INTEGRATED DISTRIBUTION SYSTEM PLANNING FOR
ELECTRIC UTILITIES,**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that, pursuant to Order No. 22723, on Wednesday, February 11, 2026, the Commission will convene the first Integrated Distribution System Planning Working Group (“IDSP WG”) meeting from 1 PM to 3 PM.¹ The IDSP WG meetings shall be virtual and led by Energy and Environmental Economics (“E3”), the consultant procured for this process.²

2. All persons interested in attending the working group meeting shall register with the Commission Secretary by 5 PM EST on Friday, February 6, 2026. Registration can be completed by sending an email to psc-commissionsecretary@dc.gov or calling (202) 626-5150. Registrants shall use the subject “FC1182 IDSP Working Group.” The Meeting Agenda and Presentation Materials will be filed in the docket by Wednesday, February 4, 2026. The virtual participation instructions will be provided to all registrants before the working group meeting.

3. Any person who is deaf or hard of hearing, who cannot readily understand or communicate in spoken English, or persons with disabilities who need special accommodations to participate in the working group meeting must contact the Commission Secretary by the close of business seven (7) days before the date of the technical conference. ² Per the Notice of Inquiry issued on November 27, 2024, the Commission engaged in a formal request for proposals process to procure a qualified consultant to lead the IDSP WG process and ensure the timely submission of the WG Report. On January 20, 2026, the Commission contracted Energy and Environmental Economics (“E3”), a nationally trusted advisor to utilities and regulators with a long track record of planning studies for clients including regulatory agencies and utilities, to lead the process.
