1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that, on October 10, 2017, Washington Gas Light Company ("WGL") filed its final reconciliation ("Final Reconciliation Filing")¹ of the Plant Recovery Adjustment ("PRA") surcharge. This surcharge recovered the costs of WGL's vintage coupling replacement and encapsulation program ("Program") approved in Order No. 15627² until it was ended in Order No. 18712.³

2. The Final Reconciliation Filing shows a \$740,478 over-collection of the PRA surcharge for the final year of the surcharge. WGL represents that the over-recovery results from the collection of the PRA surcharge from customers based on a volumetric rate, while the costs are based on a return on and of plant and depreciation, which is a fixed monthly cost recovery.⁴

3. WGL proposes to return the over-collection in a three-month period from November 2017 through January 2018. WGL indicates that this time period is different than that stated in the tariff, which includes a twelve-month period for reconciliation of the previous year's PRA surcharge. WGL requests that the Commission approve the accelerated return of the funds

to customers in this final year. WGL includes two filings that show a three month return (Attachment A) and a twelve month return (Attachment B) for the Commission's review.⁵

4.
