GD2019-04-M, IN THE MATTER OF THE IMPLEMENTATION OF THE 2019 CLEAN ENERGY DC OMNIBUS ACT COMPLIANCE REQUIREMENTS,

- 1. In Order No. 21938, the Public Service Commission of the District of Columbia ("Commission") reviewed the Clean Energy Act Implementation Working Group's ("CEAIWG") Report and Recommendations on the development of a standardized benefit-cost analysis ("BCA") framework for the Commission. The Commission adopted several of the CEAIWG's Recommendations and opened a two part Phase 2 of this proceeding. The Commission held that in Phase 2, Part A, it will develop a standardized Societal Cost Test ("SCT") and Total Resource Cost Test ("TRC") framework within six months from the date a contract is executed between the Commission and its consultant. The developed model was directed to be further refined in Phase 2, Part B, within 12 months from the date a contract is executed between the Commission and its consultant. The Commission also ordered that, after a draft of the BCA has been developed in Phase 2, Part A, the Commission will release the draft for public comments.
- 2. The draft BCA has been completed by the consultant and presented to the Commission. The BCA Model Guidebook, which provides user guidance for the BCA Model and the methodology and calculations used in the Model for Part A, was filed and docketed in Case No. GD2019-04-M. The BCA Model will be filed in the same Docket prior to the Technical Conference scheduled below. Notice of the filing of the Model will be posted on the Commission's website, and interested persons will be able to access the Model through the Commission's website at www.dcpsc.org. Once at the website, open the "eDocket" tab, click on "Search Current Dockets," and input "GD-2019-04-M" as the case number.
- 3. In order for stakeholders and other interested persons to obtain a better understanding of the BCA Model prior to the submission of their comments, the Commission is scheduling a Technical Conference to be conducted by Commission Staff and the Commission's consultants to discuss the Model and to respond to questions from stakeholders and other interested persons. That Technical Conference will be convened on February 20, 2025, from 2:30-4:30 PM in the Commission's 8th Floor Hearing Room.
