NOTICE OF CANCELLATION OF PUBLIC INTEREST HEARING

PREVIOUSLY SCHEDULED ON JUNE 4, 2018, 1:00 P.M.

FORMAL CASE NO. 1150, IN THE MATTER OF THE APPLICATION OF POTOMAC ELECTRIC POWER COMPANY FOR AUTHORITY TO INCREASE EXISTING RETAIL RATES AND CHARGES FOR ELECTRIC DISTRIBUTION SERVICE, and

FORMAL CASE NO. 1151, IN THE MATTER OF THE IMPACT OF THE TAX CUTS AND JOBS ACT OF 2017 ON THE EXISTING DISTRIBUTION SERVICE RATES AND CHARGES FOR POTOMAC ELECTRIC POWER COMPANY AND WASHINGTON GAS LIGHT COMPANY

The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that the public interest hearing scheduled to be held on Monday, June 4, 2018, at 1:00 p.m. in the Commission Hearing Room, 1325 G Street, N.W., Suite 800, Washington, DC 20005, pursuant to Section 130.11 of the Commission’s Rules of Practice and Procedure¹ to consider the Non-Unanimous Full Settlement Agreement and Stipulation (“Settlement Agreement”) filed by the Potomac Electric Power Company, the Office of the People’s Counsel for the District of Columbia, the Apartment and Office Building Association of Metropolitan Washington, the District of Columbia Government, the Maryland DC Virginia Solar Energy Industry Association, D.C. Climate Action, Baltimore-Washington Construction and Public Employees Laborers’ District Council, Tesla, Inc., Small Business Utility Advocates, and DC Consumer Utility Board and Solar United Neighbors on April 17, 2018, in *Formal Case Nos. 1150 and 1151*² is **CANCELLED**.

Cancellation of the public interest hearing is a result of all the parties’ waiver of cross-examination of the witnesses and stipulations as to the admissibility of testimony and exhibits, thus rendering the convening of the hearing unnecessary. Briefs from all the parties are due on or before June 14, 2018.
