AMENDED PUBLIC NOTICE

November 16, 2023

**FORMAL CASE NO. 1130, IN THE MATTER OF THE INVESTIGATION INTO
MODERNIZING THE ENERGY DELIVERY SYSTEM FOR INCREASED
SUSTAINABILITY,**

1. By this Notice, the Public Service Commission of the District of Columbia (“Commission”) hereby modifies its Public Notice issued October 25, 2023, by extending the deadlines for comments on the Value of Distributed Energy Resources (“VDER”) Study submitted by Synapse Energy Economics, Inc. (“Synapse”) in *Formal Case No. 1130*.¹ Comments and reply comments on the VDER Study and the inquiries listed in paragraph 3 of the initial Public Notice² are now due on May 15, 2024, and July 1, 2024, respectively.

2. By Order No. 17912, the Commission opened *Formal Case 1130*, pronouncing its intent to review the District’s energy system in light of recent sustainability goals and mandates and to “identify technologies and policies that can modernize our energy delivery system (“MEDSIS”).”³ The purpose of the VDER Study is to inform the Commission and stakeholders regarding the potential value of DER to address costs in the electric system associated with generation, transmission, and distribution. DERs include solar photovoltaics, battery storage, energy efficiency, demand response, and managed charging of electric vehicles.⁴

3. The Public Notice that was issued on October 25, 2023, set the deadlines for comments on the VDER Study within 30 days from the date of the Notice and reply comments 15 days thereafter. On November 2, 2023, Pepco filed a Motion requesting modification of the comment and reply comment deadlines to May 15, 2024, and June 30, 2024, respectively.⁵ By Order No. 21928, issued November 16, 2023, the Commission granted Pepco’s Motion.⁶

Reply Comments are now due on or before July 1, 2024. Comments should be filed with the Commission Secretary at psc-commissionsecretary@dc.gov, subject "Formal Case 1130". Copies of the VDER Study may be accessed through the Commission's website at www.dcpsec.org. Once at the website, open the "eDocket" tab, click on "Search Current Dockets," and input "FC1130" as the case number.
