OPEN MEETING SUMMARY

Wednesday, April 5th, 2022

The Public Service Commission of the District of Columbia approved one Formal Case action item at its April 5, 2023 Open Meeting:

- 1. Formal Case No. 1150, In the Matter of the Application of Potomac Electric Power Company for Authority to Increase Existing Retail Rates and Charges for Electric Distribution Service; Formal Case No. 1151, In the Matter of the Impact of the Tax Cuts and Jobs Act of 2017 on the Existing Distribution Service Rates and Charges for Potomac Electric Power Company and Washington Gas Light Company; and Formal Case No. 1156, In the Matter of the Application of the Potomac Electric Power Company for Authority to Implement a Multiyear Rate Plan for Electric Distribution Service in the District of Columbia** - This Order grants the unopposed request of Pepco in its 5-Year Excess Deferred Income Tax (“EDIT”) Filing, to eliminate the 5-year EDIT credits for rate schedules R, GT-LV, MGT-LV, and GT-3B. Pepco is also directed to submit similar compliance filings on a quarterly basis for all other remaining rate schedules when their available 5-year EDIT balances are projected to be fully credited; the filings are to be made at least 60 days in advance of the beginning of each quarter.
- 2. The next matter is also in Formal Case No. 1156 and Electric Tariff 2021-02, In the Matter of the Potomac Electric Power Company’s House of Worship and Non-Profit Customer Credit Tariff** - This Order accepts the March 17, 2023, Working Group Report and grants Pepco and OPC’s Request to extend the demand credit program for certain houses of worship and non-profit customers for an additional 90 days. Pepco is to file a compliance tariff within five days of this Order. Lastly, the Working Group is directed to convene an additional meeting on the termination, modification, or extension of the demand credit program and submit a final recommendation to the Commission by May 1, 2023.
- 3. Formal Case No. 1167, In the Matter of the Implementation of Electric and Natural Gas Climate Change Proposals** - This Order reviews the stakeholders’ legal briefs on the Commission’s authority to order electrification. The Commission recognizes the limit of its statutory authority, in that it cannot Order Washington Gas Light Company (“Company”) to end

the sale of natural gas that it is authorized to provide under its Congressional Charter. The Commission will, however, use its existing authority to reduce greenhouse gas (GHG) emissions from the Company's operations.

- 4. Electric Tariff 2022-04, In the Matter of the Potomac Electric Power Company's Proposal to Amend the Costs to Residential Customers for New Underground Service Connections Tariff -** This Order denies Pepco's Motion to update Section 10(e)(1) of the General Terms and Conditions of Pepco's Tariff increasing the fee for new underground service connections for residential customers. Pepco is directed to file a new underground service connection tariff for residential customers as part of its next base rate case filing.
