FORMAL CASE NO. 1017, IN THE MATTER OF THE DEVELOPMENT AND DESIGNATION OF STANDARD OFFER SERVICE IN THE DISTRICT OF COLUMBIA

The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that on August 1, 2013, the Potomac Electric Power Company filed, on behalf of the Standard Offer Service (“SOS”) Working Group, the proposed Wholesale Full Requirements Service Agreement (“WFRSA”) and Request for Proposals (“RFP”) for the 2013-2014 SOS Solicitation pursuant to 15 DCMR § 4101.3.¹

According to the filing, the SOS Working Group identifies proposed changes to the 2013 RFP and WFRSA. The 2013 RFP includes a proposed change to Section 2.1 to provide a reference to the proposed Renewable Energy Portfolio Standard Amendment Act of 2013, if enacted. In addition, the SOS Working Group proposes the following six changes to the 2013 WFRSA and the appropriate updates on all the relevant schedules and dates included within:

- Article 1 – Definition of “Renewable Energy Resource Requirement.”
- Article 4.4 references the proposed Renewable Energy Portfolio Standard Amendment Act of 2013.
- Article 4.10 modification that allows the Buyer and Seller to execute a revised Declaration of Authority in accordance with PJM requirements.
- Addition of Exhibit H-1, the proposed Renewable Energy Portfolio Standard Amendment Act of 2013.
- Update of Exhibit I, PJM’s Declaration of Authority.
- Update of Exhibit I-1, PJM’s Declaration of Authority Attachment A-Addendum.²
