PUBLIC NOTICE
(REVISED COMMENT PERIOD)

FORMAL CASE NO. 1175, WASHINGTON GAS LIGHT COMPANY’S APPLICATION FOR APPROVAL OF PROJECTPIPES 3 PLAN,

1. The Public Service Commission of the District of Columbia (Commission) hereby gives notice of the extension of the comment period for stakeholders to file comments with the Commission on Washington Gas Light Company’s (“WGL”) PROJECT*pipes* 3 Plan (PIPES 3 Plan), docketed in *Formal Case No. 1175*.¹

2. On December 22, 2022, WGL filed its PIPES 3 Plan seeking approval and authorization to recover the costs associated with the PIPES 3 Plan through the approved PROJECT*pipes* surcharge mechanism.²

3. On January 20, 2023, the Commission invited comments and reply comments on the matter by February 21, 2023, and March 8, 2023, respectively.³ On February 1, 2023, the Office of the People’s Counsel for the District of Columbia (OPC) filed a motion for an enlargement of time to file comments on the PIPES 3 Application.⁴ By Order No. 21573, the Commission granted the motion to allow an extension of sixty (60) days from the date of OPC’s filing of a Notice of Agency Fund Requirement (NOAFR) for comments, with an additional 14 days for reply comments.⁵ OPC indicated in the motion that the NOAFR would be filed by February 21, 2023.⁶ OPC filed the NOAFR on March 3, 2023.⁷

4. Accordingly, the Commission extends the comment period to May 2, 2023, and extends the reply comment period to May 16, 2023. Interested persons may propose a procedural schedule to facilitate adjudication of this matter and specifically identify material issues of fact that they believe are in dispute, should persons request a hearing in this matter. Comments and replies thereto shall be filed with Brinda Westbrook-Sedgwick, Commission Secretary, Public Service Commission of the District of Columbia, 1325 G Street, N.W., Suite 800, Washington,
