FORMAL CASE NO. 1160, IN THE MATTER OF THE DEVELOPMENT OF METRICS FOR ELECTRIC COMPANY AND GAS COMPANY ENERGY EFFICIENCY AND DEMAND RESPONSE PROGRAMS PURSUANT TO SECTION 201 (B) OF THE CLEAN ENERGY DC OMNIBUS AMENDMENT ACT OF 2018

The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that the Commission establishes the Energy Efficiency and Demand Response Metrics Working Group ("EEDR Metrics Working Group") and its first meeting will be on November 1, 2019. Further, the Commission is opening a new case, *Formal Case No. 1160*, to address the development of Energy Efficiency and Demand Response Metrics. The first meeting will be held from 10:00 a.m. to 12:00 p.m. in the Commission's Hearing Room – 1325 G St., N.W., Suite 800, Washington, D.C. 20005.

The CleanEnergy DC Omnibus Amendment Act of 2018 ("Act") became law on March 22, 2019, and includes, among other things, a requirement that within 90 days of the applicability date of the Act (October 1, 2019), the Commission establish a working group to develop and file "long-term and annual energy savings metrics, quantitative performance indicators, and cost-effective standards to be adopted by the Commission for electric company or gas company energy efficiency or demand response programs." Additionally, the Act directs the working group established by the Commission to consider recommendations regarding: (1) measures to ensure utility programs "do not impede District business or nonprofits currently providing energy efficiency and demand response programs;" and (2) "[p]erformance incentive mechanisms that are based on the quantitative performance indicators" the working group establishes for utility run energy efficiency and demand response programs.² The Working Group recommendations are due to the Commission within 90 days of the Working Group's first meeting.³

Persons interested in participating in the EEDR Metrics Working Group, including participants in *Formal Case No. 1148* and those interested in *Formal Case No. 1142*, Term 3, should notify the Commission of their intent to attend no later than noon, October 29, 2019, by sending an email including: (1) the participant's name and organization, if applicable; and (2) whether the
