**FORMAL CASE NO. 1017, IN THE MATTER OF THE DEVELOPMENT AND
DESIGNATION OF STANDARD OFFER SERVICE IN THE DISTRICT OF COLUMBIA**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that on September 15, 2025, the Potomac Electric Power Company (“Pepco”), acting in its role as the Standard Offer Service (“SOS”) Administrator, filed a redlined Request for Proposals (“RFP”) and confidential draft Power Purchase Agreement (“PPA”) for the long-term renewable energy PPA,¹ and that on September 18, 2025, Pepco filed the corresponding public version of the draft PPA.²

2. By Order No. 19897, the Commission, inter alia, established “a pilot program to procure renewable energy through long-term power purchase agreements for electricity generated by solar or wind power facilities located within the PJM Interconnection region with a target quantity of five (5) percent of the SOS load.”³ On July 11, 2025, Pepco filed the executed Renewable Energy Purchase Agreement.⁴ By Order No. 22702, among other things, the Commission approved the executed Renewable Energy Purchase Agreement and directed Pepco to try to procure a target quantity of twenty-five percent (25%) of the SOS load through renewable energy PPAs.⁵ The Commission also directed Pepco to file a redlined RFP and draft PPA with their proposed edits and rationale for Commission approval, if Pepco made any other changes to the RFP or draft PPA besides the target quantity.⁶

3. All persons interested in commenting on Pepco’s redlined RFP and draft PPA may submit written comments no later than fourteen (14) days after the Commission’s issuance of this Public Notice. Comments are to be sent electronically and addressed to Brinda Westbrook-Sedgwick, Commission Secretary, Public Service Commission of the District of Columbia, 1325 G Street N.W., Suite 800, Washington, D.C. 20005.
