Initial briefs, originally to be filed on or before December 11, 2015, must now be filed on or before December 16, 2015. Reply briefs, originally to be filed on or before December 18, 2015, must now be filed on or before December 23, 2015.

The Commission also directed that the record in this proceeding be closed on December 23, 2015, instead of December 18, 2015, as originally announced.
