1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that, on October 17, 2016, Washington Gas Light Company (“WGL”) filed its annual reconciliation (“2016 Annual Reconciliation Filing”)<sup>1</sup> of the Plant Recovery Adjustment (“PRA”) surcharge for 2016.<sup>2</sup> This surcharge recovers the costs of WGL’s vintage coupling replacement and encapsulation program (“Program”) approved in Order No. 15627.<sup>3</sup>

2. The 2016 Annual Reconciliation Filing shows the over- or under-collection of the PRA surcharge for the previous year. In the 2016 Annual Reconciliation Filing, WGL includes two tables. The first table shows the adjustment of the current factor to take into account the under-collection of the PRA surcharge for the period ending September 30, 2016.<sup>4</sup> The second table shows how the reconciliation factor was calculated.<sup>5</sup>
