**FORMAL CASE NO. 1017, IN THE MATTER OF THE DEVELOPMENT AND
DESIGNATION OF STANDARD OFFER SERVICE IN THE DISTRICT OF COLUMBIA,**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that the Commission will convene a Standard Offer Service (“SOS”) Working Group meeting on Tuesday, August 18, 2026. The SOS Working Group is being convened pursuant to the Commission’s directives in Order No. 22870¹ and the Commission’s ongoing biennial SOS review.²

2. The SOS Working Group meeting will be held on August 18, 2026, from 1 p.m. to 3 p.m., virtually via Microsoft Teams. The SOS Working Group Meeting will be presided over by the Commission’s Staff and will follow the attached agenda.
