**FORMAL CASE NO. 1017, IN THE MATTER OF THE DEVELOPMENT AND
DESIGNATION OF STANDARD OFFER SERVICE IN THE DISTRICT OF COLUMBIA,**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that, on April 15, 2025, Atrium Economics, LLC (“Atrium”) filed a report on the audit of the Standard Offer Service (“SOS”) administrative charge for the last six (6) years of the SOS program from June 1, 2018 until May 31, 2024.¹ By Order No. 21934, the Commission concluded the 2023 Biennial Review of the provision of SOS in the District of Columbia and determined that an audit of the last five (5) years of the administrative charge true-ups of the SOS program was reasonable in order to ensure that the costs within the administrative charge are accurate and appropriate.² By Order No. 21949, the Commission set out details for the audit and later selected Atrium as the independent auditor.³ By Order No. 21986, the Commission extended the audit by an additional year until May 31, 2024, to provide a more comprehensive analysis of recent costs in the SOS administrative charge, including those related to Community Renewable Energy Facilities.⁴

2. By this Notice, all persons interested in commenting on Atrium’s final report may submit written comments and reply comments no later than thirty (30) and forty-five (45) days after the issuance of this Notice.
