# OPEN MEETING SUMMARY

Wednesday, September 8, 2021

The Public Service Commission of the District of Columbia approved six Formal Case action items at its September 8, 2021, Open Meeting:

## FORMAL CASE ACTION

1. **Formal Case No. 1017, In the Matter of the Development and Designation of Standard Offer Service in the District of Columbia** – This Order adopts the SOS Working Group’s proposed Wholesale Full Requirements Service Agreement and Request for Proposals for the 2021 to 2022 SOS Solicitation.
2. **Formal Case No. 1125, In the Matter of the Promotion of the Utility Discount Programs** – This Order approves in part and modifies in part the Utility Discount Program Education Working Group’s Consumer Education Program Plan for Fiscal Year 2021 as described in this Order.
3. **Formal Case No. 1130, In the Matter of the Investigation into Modernizing the Energy Delivery System for Increased Sustainability** – This Order among other things, directs the Customer Impact Working Group to file a report finalizing its recommendations regarding the development of the Connect My Data platform within 90 days of the date of this Order.
4. **The Next Matter also in Formal Case No. 1130** – This Order authorizes and directs Pepco to release \$58,037.50 from the MEDSIS Pilot Project Fund Subaccount to Synapse Energy Economics, Inc., within 15 days from the date of this Order.
5. **Formal Case No. 1155, In the Matter of the Application of the Potomac Electric Power Company for Approval of its Transportation Electrification Program** – This Notice of Final Tariff (“Notice”) approves Pepco’s update to its existing Rider PIV-Green tariff effective upon publication of this Notice in the D.C. Register.

6. **Formal Case No. 1164, In the Matter of an Inquiry into the Impacts of the COVID-19 Pandemic on District Utilities and Consumers** – This Notice of Final Tariff (“Notice”) approves WGL’s RES tariff effective upon publication of this Notice in the D.C. Register.
