FORMAL CASE NO. 1119, IN THE MATTER OF THE JOINT APPLICATION OF EXELON CORPORATION, PEPCO HOLDINGS, INC., POTOMAC ELECTRIC POWER COMPANY, EXELON ENERGY DELIVERY COMPANY, LLC AND NEW SPECIAL PURPOSE ENTITY, LLC FOR AUTHORIZATION AND APPROVAL OF PROPOSED MERGER TRANSACTION

1. The Public Service Commission of the District of Columbia (“Commission”) provides notice to the parties and other interested persons of a Public Briefing on the “State of Pepco” and Merger Commitment No. 51 by the Chief Executive Officer (“CEO”) of Exelon Utilities (“EU”), the President & CEO of Pepco Holdings, Inc. (“PHI”), and the Regional President of the Potomac Electric Power Company (“Pepco”) during the Commission’s Open Meeting on January 23, 2019, at 2:00 p.m. in the Commission’s Hearing Room.

2. On June 18, 2014, Exelon Corporation, PHI, Pepco, Exelon Energy Delivery Company, LLC, and New Special Purpose Entity, LLC filed a Joint Application for approval by the Commission of a change of control for Pepco, a public utility.¹ On March 23, 2016, the Commission issued Order No. 18148, approving the proposed Pepco/Exelon Merger and associated numerous commitments.² Commitment No. 51 states:

51. EU’s CEO, the PHI CEO, the Pepco CEO, and the Pepco Regional President will annually offer to appear publicly before the Commission to review and provide documentation concerning Pepco’s reliability, safety, and customer service performance and to answer questions about Pepco’s performance in the District of Columbia. This review shall not be construed as approval of any particular Pepco program or expenditure by the Commission.

3. As this is a Public Briefing, all parties and interested persons are welcome to attend.³ The only presentation will be on the part of the presenters and questions during the Public Briefing will be limited to those of the Commissioners.
