**PUBLIC NOTICE**

**August 8, 2025**

**FORMAL CASE NO. 1125, IN THE MATTER OF THE PROMOTION OF THE UTILITY DISCOUNT PROGRAMS,**

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that on July 31, 2025, the Department of Energy and Environment (“DOEE”) filed its invoices for DOEE’s Utility Discount Program (“UDP”) administrative expenses and costs for the Consumer Education Program (“CEP”) for the Third Quarter of Fiscal Year 2025 (“FY 2025 Third Quarter”).<sup>1</sup>

2. In Fiscal Year 2025 (“FY 2025”), DOEE is the administrator for three (3) of the four (4) low-income UDPs<sup>2</sup> as well as the CEP.<sup>3</sup> As such, it performed administrative functions that are to be reimbursed by Washington Gas Light Company (“WGL”), the Potomac Electric Power Company (“Pepco”), and the District of Columbia Water and Sewer Authority (“DC Water”); and incurred CEP costs that are to be reimbursed by WGL, Pepco, DC Water, and the District of Columbia Universal Service Trust Fund (“DC USTF”). In Order No. 17246, the Commission approved a process for DOEE to request reimbursement for its expenses, which includes issuing a public notice when invoices are filed with the Commission to obtain public comment on these invoices.<sup>4</sup>

3. In its FY 2025 Third Quarter Invoices, DOEE represents that during FY 25 Third Quarter, DOEE made payments totaling \$7,823 for the following advertising costs: \$2,500 to Urban One for radio commercials; \$3,275 to the Washington Metropolitan Area Transit Authority for UDP bus advertisements; and print advertising costs of \$800 to *El Tiempo* and \$1,248 to the *Capital Community*. DOEE represents that 96% of the CEP advertising budget has been disbursed.

DOEE indicates that it also partners with community organizations and Advisory Neighborhood Commissioners to promote the UDP.<sup>5</sup>

4. The UDP administrative total for FY 2025 Third Quarter is \$135,063.19, comprising \$93,073.15 for personnel services and \$41,990.04 for database administration. The CEP total is \$26,906.33, including \$19,083.33 for personnel services and \$7,823 for advertising expenses.<sup>6</sup> The total sought by DOEE for FY 2025 Third Quarter is \$161,969.52. DOEE seeks reimbursement of \$6,272.41 from the DC USTF Administrator, \$77,530.08 from Pepco, \$45,284.71 from WGL, and \$32,882.32 from DC Water.<sup>7</sup>

5. DOEE also includes the invoices for the FY 2025 Third Quarter and several tables that provide details on the expenses incurred by DOEE in FY 2025 Third Quarter. The first table is the UDP administrative budget summary, which breaks down UDP expenditures by line item.<sup>8</sup> DOEE's next table breaks down the expenses for the CEP, itemizing the amounts spent on the various outreach programs.<sup>9</sup> The third table provides details regarding the expenses incurred for the UDP administrative budget.<sup>10</sup> The next four (4) pages are the separate invoices for the FY 2025 Third Quarter for the DC USTF, Pepco, WGL, and DC Water, itemizing the expenses.<sup>11</sup>

6. All persons interested in commenting on DOEE's FY 2025 Third Quarter Invoices may submit written comments and reply comments not later than 10 and 20 days, respectively, after the Commission's issuance of this Notice.
