FORMAL CASE NO. 1017, IN THE MATTER OF THE DEVELOPMENT AND DESIGNATION OF STANDARD OFFER SERVICE IN THE DISTRICT OF COLUMBIA,

1. The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that on March 6, 2025, the Potomac Electric Power Company (“Pepco”), as the Standard Offer Service (“SOS”) Administrator, filed its updated proposed retail rates including the administrative charges, for SOS for the period June 1, 2025, through May 31, 2026.¹ **This Notice supersedes the Notice issued on March 5, 2025, for Pepco’s March 5, 2025 filing.**² Pepco purchases generation for SOS customers through power supply contracts in an annual auction. The rates that Pepco filed with the Commission on March 6, 2025, reflect the prices in the power supply contracts awarded in the auctions held on December 9, 2024, and January 6, 2025. Pepco’s filing includes the retail rates for all the customer classes consisting of the components included in 15 District of Columbia Municipal Regulations (“DCMR”) § 4103.2.³

2. In accordance with 15 DCMR § 4103.3, interested persons may file comments and reply comments on Pepco’s submission within seven (7) and twelve (12) calendar days, respectively, from March 6, 2025.⁴ Written comments should be addressed to Brinda Westbrook-Sedgwick, Commission Secretary, Public Service Commission of the District of Columbia, 1325 G Street, N.W., Suite 800, Washington, D.C. 20005, and sent electronically on the Commission’s website at https://edocket.dcpssc.org/public/public_comments.

3. Copies of Pepco’s proposed retail rates may be obtained by visiting the Commission’s website at www.dcpssc.org. Once at the website, open the “eDocket” tab, click on “Search Current Dockets,” and input “FC1017” as the case number. Copies may also be purchased at cost by contacting the Commission Secretary at the address provided above. After the comment period has expired, the Commission will issue an Order approving or rejecting the retail rates and/or administrative charge set forth in the Pepco filing.
