1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that the Commission will hold a second educational workshop to inform stakeholders on the developments of the IEEE 1547-2018 Standard Implementation and Advanced Inverter Deployment. The Workshop is scheduled for Wednesday, December 16, 2020, from 9 a.m. to 1:30 p.m. The meeting will be held virtually via Microsoft Teams.

2. The Commission in 2015 opened the Formal Case No. 1130 proceeding to identify technologies and policies that can be implemented in the District of Columbia to modernize the distribution energy delivery system for increased sustainability (PowerPath, formerly called MEDSIS). As a result of this endeavor, the Commission commenced a stakeholder working group process which resulted in the filing of a report with recommendations for the Commission's review. One of the recommendations was to establish a stakeholder working group around IEEE 1547-2018 Standards and Advanced Inverter Deployment. As a result of this recommendation, the Commission, by Order No. 20364, directed Staff to hold an educational workshop around the standard. The Order also stated that upon the completion of the educational workshop, the Commission will consider the need for a technical conference or a working group as deemed appropriate. The Commission held an initial workshop on October 16, 2020, to discuss the basics and developments of the IEEE 1547-2018 Standard.
