FORMAL CASE NO. 1160, IN THE MATTER OF THE DEVELOPMENT OF METRICS FOR ELECTRIC COMPANY AND GAS COMPANY ENERGY EFFICIENCY AND DEMAND RESPONSE PROGRAMS PURSUANT TO SECTION 201 (B) OF THE CLEANENERGY DC OMNIBUS AMENDMENT ACT OF 2018,

1. On January 30, 2020, the Energy Efficiency and Demand Response ("EEDR") Metrics Working Group filed with the Public Service Commission of the District of Columbia ("Commission") its Report pursuant to Section 201 (b) of the CleanEnergy DC Omnibus Amendment Act of 2018, and the Commission's October 3, 2019 Public Notice, regarding standards the Commission should consider and adopt for electric company or gas company energy efficiency or demand response programs.¹ The Report addresses, and where applicable provides a recommendation as to how the Commission should consider: (1) long-term energy savings metrics; (2) annual energy savings metrics; (3) quantitative performance indicators; (4) cost-effectiveness standards; (5) measures the Commission can take to ensure programs do not impede District business or nonprofits currently operating in the District that provide EEDR programs; (6) EEDR performance incentive mechanisms; and (7) additional utility application matters for electric company or gas company energy efficiency or demand response programs.

2. By this Notice, all persons interested in commenting on the EEDR Metrics Working Group Report, may submit written comments, not later than 30 days, after the issuance of this Notice.
