IMPLEMENTATION OF INTERCONNECTION STANDARDS IN THE DISTRICT OF
COLUMBIA,**

1. The Public Service Commission of the District of Columbia (Commission) hereby gives notice that pursuant to Order No. 20991, the Commission will reconvene the RM40 Working Group on November 18, 2021. In accordance with the Commission's directives in Order No. 20991, the RM40 Working Group will continue to discuss: (1) the Potomac Electric Power Company's (Pepco) telemetry and communications requirement; (2) timelines and procedures for interconnection facilities and system upgrades; (3) the cost matrix; (4) virtual Community Renewable Energy Facility (VCREF) definitions; and (5) other issues surrounding Level 2 systems. The RM40 Working Group meeting will be held from 1pm to 3pm virtually through Microsoft Teams. Commission Staff (Staff) shall preside over the working group meeting and file meeting minutes in the above-captioned dockets within fifteen (15) days of the meeting.

2. The Commission issued a Notice on October 5, 2021, reconvening the RM40 Working Group. The meeting was held on October 19, 2021. While stakeholders made presentations on certain issues, all issues were not finalized. Therefore, Staff indicated that subsequent RM40 Working Group meetings would be held.

3. The RM40 Working Group meeting will be held on November 18, 2021, from 1 p.m. to 3 p.m. virtually through Microsoft Teams. Staff will preside over the working group meeting and file minutes in the above-captioned dockets within fifteen (15) days of the meeting. The Working Group is expected to continue discussions surrounding: (1) Pepco's telemetry and communications requirement; (2) timelines and procedures for interconnection facilities and

system upgrades; (3) the cost matrix; (4) VCREf definitions; and (5) other issues surrounding Level 2 systems.

4.
