**FORMAL CASE NO. 1130, IN THE MATTER OF THE INVESTIGATION INTO  
MODERNIZING THE ENERGY DELIVERY SYSTEM FOR INCREASED  
SUSTAINABILITY**

The Public Service Commission of the District of Columbia (Commission), in conjunction with its consultant, Smart Electric Power Alliance (SEPA), invites the general public to submit comments on the first draft report for the Modernizing the Energy Delivery System for Increased Sustainability (MEDSIS) Initiative by May 13, 2019.

Last year the Commission formed six (6) working groups in the MEDSIS Initiative which include: Pilot Projects, Non-Wire Alternatives, Data and Information Access and Alignment, Microgrids, Rate Design, and Customer Impact. There has been active and robust participation in the working group process, which includes over 217 unique participants from government agencies, industry and trade organizations, distributed energy resource and renewable energy solution providers, consumer and environmental advocacy groups, energy suppliers, and utilities. The members of these working groups have met regularly over the past eight (8) months and have formulated various recommendations that they plan to submit to the Commission for consideration at the end of May to move grid modernization forward in the District.

We believe that it is important that these draft recommendations are widely disseminated and that all interested persons, particularly those who have not been active participants in the working group process, have sufficient opportunity to provide input.
