FORMAL CASE NO. 1156, IN THE MATTER OF THE APPLICATION OF POTOMAC ELECTRIC POWER COMPANY FOR AUTHORITY TO IMPLEMENT A MULTIYEAR RATE PLAN FOR ELECTRIC DISTRIBUTION SERVICE IN THE DISTRICT OF COLUMBIA,

1. By this Notice the Public Service Commission of the District of Columbia (“Commission”) sets the schedule for comments and reply comments on Atrium Economics, LLC’s (“Atrium”) Final Audit Report and comprehensive evaluation of Potomac Electric Power Company’s (“Pepco”) Bill Stabilization Adjustment (“BSA”).¹

2. By Order No. 20755, issued June 8, 2021, as part of a comprehensive review and evaluation of the BSA, the Commission directed that an audit be conducted by an independent consultant to review the Company’s BSA operations and Pepco’s quality control procedures.² On September 21, 2022, the Commission issued an Order selecting the auditor, Atrium, and set forth a revised schedule for the remaining milestones for the BSA Audit, including the filing of comments and reply comments by the parties on the Preliminary Audit Report.³ On May 18, 2023, Atrium filed the Preliminary BSA Audit Report.⁴

3. Comments on the Preliminary Report were filed by the Office of the People’s Counsel for the District of Columbia on June 5, 2023, and by the Apartment and Office Building Association of Metropolitan Washington and Pepco on June 6, 2023. Reply comments were filed by Pepco on June 20, 2023. Atrium, the auditor, reviewed and evaluated these comments and reply comments and reflected in the Final Audit Report are any edits/modifications that they believe were warranted.

4. The Final Audit Report, having been filed on July 7, 2023, includes a few changes from the preliminary; primarily clarification language. The Commission now solicits the parties’
