**FORMAL CASE NO. 1160, IN THE MATTER OF THE DEVELOPMENT OF METRICS  
FOR ELECTRIC COMPANY AND GAS COMPANY ENERGY EFFICIENCY AND  
DEMAND RESPONSE PROGRAMS PURSUANT TO SECTION 201 (B) OF THE CLEAN  
ENERGY DC OMNIBUS AMENDMENT ACT OF 2018**

The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that pursuant to the CleanEnergy DC Omnibus Amendment Act of 2018 (“Act”), the Commission will hold the fourth Energy Efficiency and Demand Response Metrics Working Group (“EEDR Metrics Working Group”) Meeting on December 12, 2019. In accordance with Commission directives in the Act, the EEDR Metrics Working Group will continue the development of “long-term and annual energy savings metrics, quantitative performance indicators, and cost-effective standards to be adopted by the Commission for electric company or gas company energy efficiency or demand response programs.”<sup>1</sup> The fourth EEDR Metrics Working Group Meeting will be held from 9:30 a.m. to 12:30 p.m. in the Commission Hearing Room – 1325 G St. N.W., Suite 800, Washington, D.C. 20005. Commission Staff shall preside over the working group meeting and file meeting minutes in the above-captioned docket within ten (10) days of the meeting.

Persons interested in participating in the working group may review the Minutes from the prior EEDR Metrics Working Group Meeting on the Commission’s eDocket under Case Number “FC1160.”
