**FORMAL CASE NO. 1160, IN THE MATTER OF THE DEVELOPMENT OF METRICS
FOR ELECTRIC COMPANY AND GAS COMPANY ENERGY EFFICIENCY AND
DEMAND RESPONSE PROGRAMS PURSUANT TO SECTION 201(B) OF THE CLEAN
ENERGY DC OMNIBUS AMENDMENT ACT,**

The Public Service Commission of the District of Columbia (“Commission”) hereby gives notice that the Commission will hold the twelfth Energy Efficiency and Demand Response (“EEDR”) Metrics Working Group (“EEDR Metrics Working Group”) Meeting virtually via Microsoft Teams from 10:00 a.m. to 12:30 p.m. on Thursday, March 30, 2023. In accordance with Commission directives in Order No. 20654 and the CleanEnergy DC Omnibus Amendment Act of 2018, the EEDR Metrics Working Group is to continue to consider unresolved issues such as the governance structure to coordinate the planning, delivery, reporting, evaluation, and design of EEDR programs administered by the utilities, and EEDR performance incentive measures.

The twelfth EEDR Metrics Working Group Meeting is being held at the request of the District of Columbia Sustainable Energy Utility’s (DC SEU’s) Advisory Board as set forth in its letter to the Commission dated February 16, 2023, to enable the Working Group to convene before Washington Gas Light Company (“WGL” or “Company”) submits its proposals to the Commission, now due to be filed April 28, 2023. The purpose of this twelfth meeting is to permit Working Group members to consider WGL’s forthcoming EEDR proposals and to discuss formal solicitation of comments and implications of the Company’s Potential Study, which was filed on October 31, 2022.

Persons interested in participating in the working group may review the minutes from the prior EEDR Metrics Working Group Meetings on the Commission’s eDocket in *Formal Case No. 1160*.
