**FORMAL CASE NO. 1178, IN THE MATTER OF THE PETITION FOR INVESTIGATION  
INTO WASHINGTON GAS LIGHT COMPANY'S SYSTEM LEAK REDUCTION  
PRACTICES**

1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that the Commission will hold a technical conference in *Formal Case No. 1178* on Tuesday, August 25, 2026, from 11:00 a.m. to – 1:00 p.m. in the Commission's Hearing Room. The material to be presented may be confidential, and attendance may be restricted to protect the information presented.

2. By Order No. 22004, the Commission directed Washington Gas Light Company ("WGL") to prepare materials to present at a technical conference on multiple topics relating to leak management in the District of Columbia. This technical conference will address leak reporting, the use of GIS mapping for leaks, and evaluate the need for public access to recorded and/or repaired leaks.<sup>1</sup>

3. All persons interested in commenting on GIS mapping methods for recording leaks may submit written comments not later than Monday, August 24, 2026. Comments should be filed with the Commission Secretary at [psc-commissionsecretary@dc.gov](mailto:psc-commissionsecretary@dc.gov). All presentations must be filed with the Commission by Friday, August 21, 2026.

4. Parties who plan to attend the presentation must notify the Commission in advance, no later than August 21, 2026, by contacting Hunter Davis at [hdavis@psc.dc.gov](mailto:hdavis@psc.dc.gov). The technical conference will be convened in person. Participants may request virtual attendance, subject to a limited list of attendees.
