**PUBLIC NOTICE**

**FORMAL CASE NO. 1178, IN THE MATTER OF THE PETITION FOR  
INVESTIGATION INTO WASHINGTON GAS LIGHT COMPANY'S SYSTEM LEAK  
REDUCTION PRACTICES,**

1. The Public Service Commission of the District of Columbia ("Commission") hereby gives notice that the Commission will hold an in-person technical conference in *Formal Case No. 1178* on Wednesday, November 12, 2025, 1:30 pm – 3:00 pm, in the Commission Hearing Room. This notice reschedules the in-person technical conference in *Formal Case No. 1178*, which was originally planned to be held on Wednesday, November 5, 2025.

2. By Order No. 22004, the Commission directed Washington Gas Light Company ("WGL") to prepare materials to present at a technical conference on multiple topics relating to leak management in the District of Columbia. This technical conference will address a review of WGL's reporting methods for natural gas leaks in the District, currently maintained in the Leak Identification, Detection and Repair, and Odor Complaints ("LIDAROC") master database, in compliance with the Natural Gas Quality of Service Standards incorporated in Chapter 37 of the Commission's Rules.<sup>1</sup> The Commission seeks a continuation of the October 9, 2025, discussion on how reporting requirements may be maintained or adjusted in the future for a reliable source of leak information.<sup>2</sup>

3. All persons interested in commenting on LIDAROC reporting methods may submit written comments not later than Friday, November 7, 2025. Comments should be filed with the Commission Secretary at [psc-commissionsecretary@dc.gov](mailto:psc-commissionsecretary@dc.gov).
