NOTICE OF PROPOSED TARIFF**ELECTRIC TARIFF 2019-02, IN THE MATTER OF THE PROPOSAL OF THE POTOMAC ELECTRIC POWER COMPANY TO AMEND ITS RATE SCHEDULES FOR ELECTRIC SERVICE IN THE DISTRICT OF COLUMBIA TARIFF, P.S.C.-D.C. No. 1,**

1. The Public Service Commission of the District of Columbia (Commission) hereby gives notice, pursuant to Section 34-802 of the District of Columbia Official Code and in accordance with Section 2-505 of the District of Columbia Code,¹ of its intent to act upon the filing of the Potomac Electric Power Company's (Pepco or Company) proposing to amend Pepco's Sustainable Energy Trust Fund Surcharge Rider "SETF" (Rider SETF) tariff in not less than thirty (30) days from the date of publication of this Notice of Proposed Tariff (NOPT) in the *D.C. Register*.

2. On September 29, 2025, Pepco filed a tariff amendment requesting Commission approval of an update to the SETF tariff due to a change in law, D.C. Act 26-148, creating the Mayor's Energy Surcharge Fund (MESF).² The Company explains that the MESF is intended to fund wind and solar energy for the District of Columbia through Purchase Power Agreements and is to be collected by Pepco. The Company proposes that the rate for the SETF be reduced, while the rate for the MESF be equal to that reduction amount. Thus, according to Pepco, the overall rate at which it collects will not change. Given the relationship between the SETF and MESF, Pepco proposes to collect both amounts through the Rider SETF surcharge. The proposed tariff language states:

Effective October 1, 2025, through D.C. Act 26-148, the District of Columbia established the Mayor's Energy Surcharge Fund ("MESF") to purchase wind or solar energy by the District of Columbia Government. Rider "SETF" will also, beginning on October 1, 2025, include amounts collected for the MESF.³

Pepco proposes to amend the following tariff pages to reflect the update in the Rider SETF:
