Question 1

Could you clarify the anticipated budget range for this project to ensure our financial alignment?

Are there specific modeling tools or software preferred for the forecasting and scenario analysis tasks?

Question 13

Please confirm whether or not any allowance for travel expenses should be included in the cost proposal.

Question 14

Please clarify whether all Past Performance Forms must be included with the initial proposal or whether they may be submitted afterwards.

Answer to Question 14

A minimum of three (3) Past Performance Forms shall be submitted with the initial proposal, see Section D.4.2.3.

Question 15

Please clarify the meaning of the statement in Section E.3: The Offeror shall submit a separate technical and price proposal for each category of work.

Answer to Question 15

Question 16

Regarding RFP Section E.3.6, please clarify whether the Certificate of Good Standing and Certificate of Authority are required only for corporations and not for individuals or limited liability companies located outside of the District. Clarify whether they can be obtained after an award.

Question 17a

Please clarify what, if anything, must be submitted with the proposal in connection with the use of SBEs.

Answer to Question 17a

If a Prime Offeror chooses to subcontract any portion of the work with an SBE/CBE, the Prime Offeror must complete **Attachment E**, SBE Subcontracting Plan.

Question 17b

Please also confirm that a firm may submit a proposal with no planned SBE participation.

Answer to Question 17b

Yes, a firm may submit a proposal with no planned SBE/CBE participation.

Question 18

Can an Offeror bid on Phase 1 and Phase 2 only?

Answer to Question 18

The intent of this RFP is for a single Consultant to perform all three (3) phases of the work to develop the IDSP framework. Offerors should disclose any potential conflict of interest on Attachment B, Disclosure/Conflict of Interest Statement.

2. Delete in its entirety: E.3.6 Corporate Information

and replace with:

"Offerors, if incorporated, shall attach to the proposal, a current franchise tax Certificate of Good Standing, issued by the District of Columbia Comptroller's Office. Offerors shall provide to the Commission, Offeror's 9-digit Federal Employer's Identification Number (FEI#) or Social Security Number (SSN) if the Offeror is an individual. If a domestic corporation, Offerors shall also provide to the Commission the corporation's charter number issued by the District of Columbia Department of Licensing and Consumer Protection. If a foreign corporation, Offerors shall also provide to the Commission a copy of a valid Certificate of Authority to do business in the District of Columbia, issued by the District of Columbia Department of Licensing and Consumer Protection.
