# **SECTION I. Questions and Answers**

## **Question 1**

Does PSC (or anyone else) maintain a list of local or preferred SBE/CBE contacts?

## Question 2

Regarding the Transactive Neighborhood Renewable Microgrid Pilot Project, in section B.1.1.2 (GHG Emissions Reductions), would the use of Renewable Natural Gas (RNG) offsets be eligible as a means to fulfill the reduction in GHG emissions requirement?

#### Answer

The RFP states that GHG Emissions Reductions should demonstrate a decrease in GHG emissions as a result of the project replacing the use of fossil fuels, reducing energy demand, preventing the need for new fossil fuel infrastructure, or reducing electricity consumption during periods when grid electricity from PJM has a high fossil fuel content. Offerors are encouraged to effectively demonstrate how their microgrid technology achieves this outcome in their proposal.

## **Question 3**

Am I ineligible to submit a proposal if I have had a business relationship with Pepco, its affiliates, or its parent company Exelon; in Washington Gas Light Company (WGL"), its affiliates, or its parent company Alta Gas?

## <u>Answer</u>

Offerors shall complete Attachment B, Disclosure Statement and, in addition, disclose the information required by Section A.3 (c), as amended. See Section II of this Addendum.

Offerors shall complete Attachment B and, in addition, identify any financial or ownership interest by employees of the company in Pepco, its affiliates, or its parent company Exelon; in Washington Gas Light Company ("WGL"), its affiliates, or its parent company Alta Gas; and disclose the nature of any funding received from Pepco, Exelon, or their subsidiaries and affiliates, and WGL, AltaGas, or their subsidiaries and affiliates in the past three years. Offerors must also disclose any financial relationship with a Pilot Project Governance Board member.
