FORMAL CASE NO. 945, IN THE MATTER OF THE INVESTIGATION INTO ELECTRIC SERVICES MARKET COMPETITION AND REGULATORY PRACTICES, Order No. 16528

- 1. On August 1, 2011, Mayor Vincent C. Gray signed into law the Distributed Generation Emergency Amendment Act of 2011. The Act, *inter alia*, directs the Public Service Commission of the District of Columbia ("Commission"), after January 31, 2011, not to certify any solar energy facilities not located within the District or not in locations served by a distribution feeder serving the District as eligible District of Columbia renewable energy standards generating facilities.²
- 2. When the Act became law on August 1, 2011, there were a number of applications pending before the Commission for certification of such facilities. A list of those applications is contained in the appendix to this Order.

THEREFORE, IT IS ORDERED THAT:

3. All applications for certification as eligible District of Columbia renewable energy standards generating facilities of solar energy facilities not located within the District, nor in locations served by a distribution feeder serving the District, pending before the Public Service Commission of the District of Columbia on August 1, 2011 are hereby **DENIED**.
